



## The “GEI AWARD 2017” Goes to Gilberto Benetton



The “GEI AWARD 2017” will be awarded to Gilberto Benetton, Chairman of Autogrill, as announced by the president of GEI - Gruppo Esponenti Italiani, Lucio Caputo.
